CALL TO ORDER: Chairperson Channell called the meeting to order at 9:50 am.

RESOLUTION; IMPOSING A TEMPORARY OVERSIZED VEHICLE RESTRICTION ON A CERTAIN PORTION OF COUNTY ROAD 742, ALSO KNOWN AS TAYLOR RIVER ROAD: Assistant County Manager Marlene Crosby was present for discussion.

Assistant County Manager Crosby explained that this restriction would apply in two places. She also confirmed that the restrictions can be lifted in time for the upcoming bike race. Although the County does not have the primary responsibility of noticing the public, she agreed to notice the restriction. She will also require use of an electronic road sign. **Moved** by Commissioner Swenson, seconded by Commissioner Chamberland to adopt Resolution #2012-20, a Resolution Imposing a Temporary Oversized Vehicle Restriction on a Certain Portion of County Road 742 also known as Taylor River Road and authorize signatures. Motion carried unanimously.

**THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF GUNNISON, COLORADO
RESOLUTION NO: 12-20**

A RESOLUTION IMPOSING A TEMPORARY OVERSIZED VEHICLE RESTRICTION ON A CERTAIN PORTION OF COUNTY ROAD 742 ALSO KNOWN AS TAYLOR RIVER ROAD

WHEREAS, the Board of County Commissioners of the County of Gunnison, Colorado, (hereinafter the "Board") has the legal authority to regulate and control the use of certain highways and roads in Gunnison County, Colorado; and

WHEREAS, pursuant to C.R.S. § 42-4-111 (1)(v) and C.R.S. §18-9-117(1)(b),(c), and (f) the Board has the authority to adopt temporary regulations as may be necessary to address special conditions of roads and county property; and

WHEREAS, County Road 742 also known as Taylor River Road (hereinafter "County Road 742") is currently being constructed; and

WHEREAS, as a result of the reconstruction of County Road 742 certain traffic constraints have developed; and

WHEREAS, because of those certain traffic constraints, in the best interest of public health, safety and welfare, it would be prudent to impose a temporary oversized vehicle restriction; and

WHEREAS, the oversized vehicle restriction that has been recommended is to limit the width of vehicles to no more than eight feet six inches (8'6") and to limit the length of vehicles to no more than eighty feet (80') on that portion of County Road 742 between Mile Marker 12 and Mile Marker 15; and

WHEREAS, the restriction shall begin upon execution of this resolution until August 31, 2012 and shall not apply to those vehicles necessary to perform the reconstruction of County Road 742; and

WHEREAS, imposing a temporary restriction on oversized vehicles will not adversely affect health and safety nor will it cause substantial injury to the owner(s) or occupant(s) of adjacent land(s); and

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Gunnison, Colorado, that a temporary oversized vehicle restriction to limit the width of vehicles to no more than eight feet six inches (8'6") and to limit the length of vehicles to no more than eighty feet (80') shall be and hereby is imposed on that portion of County Road 742 between Mile Marker 12 and Mile Marker 15 for a period of time beginning upon execution of this resolution until August 31, 2012 with the EXCEPTION that this restriction shall not apply to those vehicles necessary to perform the reconstruction of County Road 742.

INTRODUCED by Commissioner Swenson, seconded by Commissioner Chamberland, and adopted this 10th day of July, 2012.
