



**BOARD OF COUNTY COMMISSIONERS OF GUNNISON COUNTY
RESOLUTION NO. 12-15**

**A RESOLUTION ADOPTING AN AMENDED SCHEDULE OF FEES
FOR THE COMMUNITY DEVELOPMENT DEPARTMENT PERMIT APPLICATIONS**

WHEREAS, pursuant to the Gunnison County Land Use Resolution and the Gunnison County Individual Sewage Disposal Regulations, the Board of County Commissioners is authorized to set and amend the Community Development Department's permit application fees in order to compensate the County for the cost of reviewing and processing applications for permits; and

WHEREAS, Community Development Department staff has provided the Board of County Commissioners a cost allocation analysis of land use change and individual sewage disposal permit reviews and a comparison of other jurisdictions' application fees; and

WHEREAS, the Board of County Commissioners is informed of the costs associated with the review of certain land use change permit and individual sewage disposal system permit applications; and

WHEREAS, the Board of County Commissioners has not increased land use change or individual sewage disposal system permit application fees since 2000.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Gunnison County, Colorado:

1. The Community Development Department amended Schedule of Fees for specific land use change and individual sewage disposal system permit applications is hereby adopted, attached hereto.
2. The Community Development Department Schedule of Fees, for all land use change and individual sewage disposal system permit applications, shall be adjusted annually, on January 1 of each year, rounded to nearest five dollars, based upon the National Consumer Price Index for All Urban Consumers (CPI-U), as established by the United States Department of Labor - Bureau of Labor Statistics.
