CALL TO ORDER: Chairperson Swenson called the meeting to order at 1:00 pm.

VOUCHERS AND TRANSFERS APPROVAL: Finance Director Linda Nienhueser presented the voucher approval report dated July 23, 2013 and the cash transfer authorization dated June 2013 for discussion and approval. **Moved** by Commissioner Chamberland, seconded by Commissioner Houck to approve the vouchers in the amount of \$2,783,233.89. TREASURER'S MONTHLY REPORT: County Treasurer Melody Marks presented the June 2013 Treasurer's report; an investment report dated June 30, 2013; a quarterly interest report for April through

June 2013; and a semi-annual financial statement for January 1, 2013 through June 30, 2013 for discussion and acceptance. **Moved** by Commissioner Chamberland, seconded by Commissioner Houck to accept the Treasurer's report. Motion carried unanimously.

RESOLUTION; REPEALING RESOLUTION NO: 2013-13, A RESOLUTION IMPLEMENTING STAGE 1 FIRE RESTRICTIONS: County Attorney David Baumgarten, Emergency Manager Scott Morrill, Undersheriff Randy Barnes and Fire Marshall Dennis Spritzer were present for discussion.

Fire Marshall Spritzer informed the Board that all related indicators suggested that it was safe to lift the restrictions. He noted that the Bureau of Land Management and the Forest Service were similarly lifting the restrictions on their lands. Undersheriff Barnes and Emergency Manager Morrill agreed with his assessment. Since the implementation of the fire restrictions, there have been four or five lightning-caused fire starts, and there have not been any human-started fires. Moved by Commissioner Houck, seconded by Commissioner Chamberland to adopt Resolution #2013-18, a Resolution Repealing Resolution No: 2013-13, a Resolution Implementing Stage 1 Fire Restrictions. Motion carried unanimously.

ADJOURN: **Moved** by Commissioner Chamberland, seconded by Commissioner Houck to adjourn the meeting. Motion carried unanimously. The meeting adjourned at 1:11 pm.

RESOLUTION NO. 2013-18**

A RESOLUTION REPEALING RESOLUTION NO: 2013-13, A RESOLUTION IMPLEMENTING STAGE 1 FIRE RESTRICTIONS

WHEREAS, on June 18, 2013, as a result of increased danger of wildfires in unincorporated Gunnison County, the Board of County Commissioners of the County of Gunnison, Colorado (hereinafter the "Board") passed Resolution No: 2013-13, "*A Resolution Implementing Stage One Fire Restrictions*" and

WHEREAS, as a result of consistent rainfall, the danger of wildfires has since been significantly reduced in Gunnison County; and

WHEREAS, staff has advised the Board that it would be safe to repeal Stage One Fire Restrictions identified in Resolution No: 2013-13 and the Board wishes to repeal the Stage One Fire Restrictions in unincorporated Gunnison County effective July 23, 2013 upon execution by the Board.

NOW THEREFORE, be it resolved by the Board of County Commissioners of the County of Gunnison, Colorado, that Resolution No: 2013-13, "*A Resolution Implementing Stage One Fire Restrictions*", shall be and hereby is repealed effective July 23, 2013 upon execution by the Board.
