**DRAFT Marijuana regulations:** the Gunnison County Planning Commission conducted a work session with possible action. They reviewed the draft marijuana regulations for the cultivation, manufacturing and testing of marijuana in unincorporated Gunnison County, and the proposed amendment to the *Land Use Resolution*.
