

WHEREAS, the Board has reviewed Appendix A and has determined that it is appropriate to cancel the taxes identified on Appendix A;



INTRODUCED by Commissioner Houck, seconded by Commissioner Messner, and adopted this 25th day of ~~August~~ July, 2017.




