

**Gunnison County  
Workers' Compensation Designated Medical Provider List**

When an employee is injured on the job it must be reported immediately so to assure quality medical care is provided in a timely manner. The first priority after an injury is to get appropriate medical care. If your work related injury requires emergency response; if you are transported to the nearest medical facility, or if the injury occurs after normal business hours or on a weekend, you **must** follow up with one of our designated Workers' Compensation providers as soon as possible. Also, please call the county's workers' compensation claim contact immediately to report the injury and address any questions. The county's contact is as follows:

On occasion another provider in the office may see you if you make an appointment on short notice or if your designated provider is unavailable. However, you must resume seeing your designated provider for all subsequent visits.

The county's workers' compensation insurance is provided by the County Workers' Compensation Pool (CWCP) and claims are administered by County Technical Services, Inc. (CTSI). All reasonable and necessary, authorized treatment related to your injury will be paid by the CWCP. You will also be reimbursed for mileage to and from medical or therapy appointments.
