If the requested permit is granted, the undersigned acknowledges, accepts and agrees to the restrictions initialed above and the following terms and conditions:

1. Take every precaution to protect the road and the public from damage or injury, using pilot cars or flagmen to warn the traveling public on all blind curves, both vertical and horizontal.
2. In case of over wide loads, the same is to be placed on the vehicle with the over hangings as far to right as possible, and in any event the material shall be loaded so as to present the minimum hazard to traffic.
3. Make this trip only between DAYLIGHT and DARK, and to remove the oversized load from the road except between those hours.
4. Be financially responsible and to make prompt payment for damage caused to the traffic, to traffic lights, overhead signs, wires, cables, and other installations or for any damage caused to the roads or bridges by the transportation of this vehicle or load.
5. Ensure that the operator of the vehicle or vehicles is duly licensed according to statute.
6. Operate the vehicle or vehicles at all times with any and all provisions of law, except as exempted herein, with regard to motor vehicles and the operation thereof.
7. This Special Transport Permit is not valid unless a copy of the permit accompanies the oversized vehicle.
8. Except when a permit is requested and granted for over-weight, the undersigned applicant specifically states that his/her load is legal weight, and the same cannot be loaded to conform with the statute. He/She certifies that he/she understands and accepts all provisions and requirements of this permit.
9. Be responsible for all overhead clearances.
10. Movement of oversized loads during the school year is restricted from 7:30 a.m. to 9:00 a.m. and 3:30 p.m. to 4:30 p.m. (See State Patrol communication revised 4/1/2000).
11. If the load is over 150,000 pounds, the operator shall provide the axle configuration to the Gunnison County Public Works Department.

12. Applicant agrees to indemnify and hold harmless Gunnison County, its officers, employees, and appointed officials from all suits, actions or claims of any character whatsoever brought because of any injuries or damage received by any person, persons or property arising from the issuance or use of this permit.
13. Gunnison County Public Works Department may require additional requirements on a case by case basis.
14. This permit shall apply only to the company and vehicle identified herein and there shall be no transfer or conveyance whatsoever of the permit.
15. The permittee agrees that permittee shall pay Gunnison County's costs and attorney's fees for enforcement of the requirements of this permit.
16. **OVERWEIGHT PERMITS WILL BE SUSPENDED BETWEEN THE MONTHS OF APRIL THROUGH JUNE DUE TO SPRING RUNOFF AND SOFT ROADS. WRITTEN PERMISSION MAY BE APPROVED BY THE GUNNISON COUNTY PUBLIC WORKS DEPARTMENT ON A CASE BY CASE BASIS DURING THESE MONTHS.**

Failure to perform and abide by the above terms and conditions shall result in revocation of the permit. It is acknowledged, accepted and agreed by the applicant that this permit when issued is **ONLY** valid on those roads under the jurisdiction of the Gunnison County Public Works Department. To operate on roads under other jurisdictions, it is necessary to obtain a separate permit from the local authorities having jurisdiction there over.

This application, when signed by the Gunnison County Public Works Director or designee, in the space below, becomes the requested permit subject to above terms and conditions and, with the understanding that, no liability is assumed by the Department by reason of its issuance, in regard to condition of roads or capacity of culverts and bridges, and the applicant is charged to make necessary examination and inspection as to the adequacy of roads and bridges to care for the traffic movement. In case of emergency, Public Works Director or a representative have authority to suspend this permit until emergency conditions have passed.

THIS PERMIT IS NOT VALID: Saturday P.M., Sunday, or Holidays and becomes VOID during blizzard, heavy snow or icy road conditions.

Permission is hereby given to the applicant to move or haul a load of greater weight or dimension than specified by law.
